

Wyjaśnienie do ustalenia wartości zamówienia dot. „Przebudowa – rozbudowa wjazdów do garaży w budynku OSP w Jegłowniku przy ul. Szkolnej 2”

Załącznik nr 4

W związku z otrzymaną prośbą o udzielenie wyjaśnień dotyczących ustalenia szacunku zamówienia polegającego na „Przebudowa – rozbudowa wjazdów do garaży w budynku OSP w Jegłowniku przy ul. Szkolnej 2” informuję, że:

1. Dokumentacja wykonana dla tego zadania pierwotnie zakładała wykonanie prac budowlanych w innej technologii niż w zamówieniu. Zakres prac obejmował całość projektu budowlanego, natomiast zmianie uległ sposób ich wykonania (zmiana technologii).

W związku z tym koszty wykonania przedmiotu zamówienia również uległy zmianie (zmniejszeniu – specyfika technologii) w odniesieniu do pierwotnego kosztorysu inwestorskiego zakładającego zastosowanie technologii murowanej.

2. Szacunku kosztów dokonano poprzez rozeznanie rynkowe z uwzględnieniem nowego sposobu wykonania zadania, bez zmiany zakresu projektu budowlanego.
3. Zapisów ustawy – Prawo zamówień publicznych nie stosuje się w zamówieniach poniżej 130 tysięcy zł netto. Z uwagi na zmianę technologii wykonania prac budowlanych (technologia mniej kosztogonna i szybsza) wartość wykonania zamówienia znajdowała się poniżej wartości zamówień do których zastosowanie ma ustawa Prawo Zamówień Publicznych.
